Sam & Abhi are gym-trainers in Core Gym, a high-class gym in the city of Agrabah. They are employed by Swapnil. The gym was running smooth and all the members were also happy. Both Sam & Abhi were very hard working and dedicated employees. As the popularity of the gym soared the number of members also increased. Initially, it was manageable. The number of members didn't affect the working of the gym at all. Swapnil tried to use the soaring popularity to attract as many people as possible. He didn't consult with Sam & Abhi regarding the intake of members. There were a lot of complaints from both regarding each other. Shyam's profile on Vaada.com stated that his height was 5'8" which in reality was 5'6. It also stated that he has a big business and has an influential background, but the reality was completely different. He used to work as a store manager and had a middle-class status in the society. Reema on the other hand had also concealed a few things about her personal life. Her family hid the fact that she had taken a debt for her recent marriage & also that she had been married earlier and this is her second marriage.

All these issues created a lot of hatred amongst them and it was a not possible for them to live together. It was clear that the marriage was not going to work and both decided that separating was the best option for them. Reema left Shyam and went back to live with her parents. The credit for their success goes to their star player 6-time "player of the year" in football Mr. Espionage Fanta. Mr Fanta was made captain in 2020 & since been the captain for the last 3 years. During this period FC Temorselona has been deteriorating, facing continuous knockouts. Recently, in the Continental Championship Football, F.C. Temorselona suffered a humiliating defeat against Harmony 's (Harmony is a neighbouring country of Frane) opposition side F.C. Bavarian by a margin of of 7-2. Since the defeat, Mr Fanta has been very upset and unhappy with the deteriorating state of the club. The trainers for FC Temorselona have been changed over frequently, resulting in poor team management and game tactics. Additionally, no new players were signed by the club in recent transfer markets, resulting in a pathetic player performance chart.



He said that since the contract terminates after every tournament, he must be allowed to leave without a transfer fee. The contract stipulated that if Mr Fanta were to leave in the middle, the requesting club would have to pay \$600 Million.

The club management argued that Mr. Fanta should have asked to leave in the month of March as the contract ended in that month. But due to the sudden cancellation of matches because of unavoidable reasons, the Continental Championship Football had to be played in the month of July. Hence, Mr Fanta cannot be allowed to leave for free and the requesting club will have to pay \$600 Million.

Mr Fanta through his father reportedly conveyed to the club management that due to the cancellation of matches, the contract stands extended. In lieu of the same, he has the authority to leave the club unconditionally.
